Extended Hours

This year, we will again offer extended hours for all grades between 7:45 am until 5:00 pm. The cost per day is \$20. You must prepay for the month. This cost is not subject to financial aid. You may incur a late fee in the amount of \$5 for every 5 minutes you are late.

Financial aid
